

## Graduate Student Experiences During the COVID-19 Pandemic


In order to understand how students were faring during the rapid changes to instruction and daily life during the COVID-19 pandemic, the Student Affairs Information and Research Office (SAIRO) worked with campus stakeholders to develop questions to be included the Student Affairs Graduate and Professional Student Survey (GPSS) in Spring 2020. This report includes the final summary charts of key content areas that were summarized at various points during the Spring and Summer terms to inform campus decision-making. 



### Not getting a job after graduation is a prominent concern



## Accessing safe transportation and caring for family members are prominent challenges


% reporting "challenges due to COVID-19" (mark all that apply)

I have every credit I need. All that is left to do is do my thesis project. There is no point to taking more classes and running up more student loan debt.

I hope to finish my dissertation in August, but it partially relies on some childcare over the summer (camps) so I can have quiet, focused time to write. Another consideration is the job market. If there are no jobs, I may drag my heels and stick around a little longer for at least some income and healthcare as a GSR.
